

## **Tuition Waiver for Children of a 100% Disabled New Hampshire Veteran**

The University System of New Hampshire institutions will award tuition waivers to children of totally and permanently 100% disabled New Hampshire veterans when all eligibility requirements are met.

### **Eligibility Requirements**

Applicant must be a child of a totally and permanently disabled veteran residing in New Hampshire, [effective June 17, 2022 - OR a child of a totally and permanently disabled veteran who resided in New Hampshire at the time of their death], and be under the age of 27 on the first day of term during which the child intends to use the waiver.

### **APPLICATION PREREQUISITES (to be completed prior to applying for the waiver):**

- a) Apply and receive acceptance to, or currently be enrolled at any University System of New Hampshire institution: Granite State College, Keene State College, Plymouth State University, University of New Hampshire-Durham, University of New Hampshire-Manchester
- b) Enroll in an eligible USNH academic program that leads to the award of an undergraduate certificate, associate degree, or a first bachelor's degree that is approved to receive Title IV federal financial aid
- c) Meet the requirements establishing New Hampshire residency (domicile) as set forth in USNH Board of Trustees Policy BOT IV.E.6.1
- d) Complete the Free Application for Federal Student Aid (FAFSA), and all required verification items.

### **APPLICATION REQUIREMENTS (additional documentation required at time of application)**

- e) Exhaust all available Ch. 33 Post 9/11 GI Bill education benefits and other federally funded military tuition assistance
- f) Utilize other federal gift aid, and institutional aid
- g) Submit a Member 4 copy of the Veterans DD-214
- h) Submit Members Summary of Benefits or other document that proves disability and rating by the U.S. Department of Veterans Affairs
- i) *Effective June 17, 2022* - If Veteran is deceased, submit a copy of their Death Certificate verifying New Hampshire residency

If approved, tuition waivers will be applied in the semester they are received and moving forward. Tuition waivers will not be applied retroactively. Reapplication for the waiver is not required unless there has been a change in eligibility or student status.

# Tuition Waiver for Children of a New Hampshire Disabled Veteran

## Application Form

Eligibility requirements include enrollment in a program leading to a certificate, associate, or first-time bachelor's degree at any University System of New Hampshire institution.

Tuition waivers will not be applied retroactively or allowed to be transferred to other individuals. Changes to award eligibility may be implemented by USNH in compliance with state law.

Individuals seeking to renew a tuition waiver must have, in the preceding academic year, demonstrated satisfactory academic progress as defined by the institution.

An eligible waiver recipient at USNH may receive up to six annual tuition waivers commensurate with 150% of the normal length of time required for completion of the certificate or degree being sought.
